**All applicants to CTC:**

CTC membership fee is paid on an annual basis (April 1<sup>st</sup> – March 31<sup>st</sup>) and is due by March 31 for the following 12 months.

- The fee is \$65.00.
- Checks should be made payable to the Cottonwood Tennis Club. Drop the **check and this form** in the Suggestion Box located at the tennis bulletin boards at Cottonwood or mail them to: Cottonwood Tennis Club, C/O Barb Jorgensen, 10922 E Sunnydale Dr., Sun Lakes, AZ 85248.
- No refunds are given.
- Applicants must be in good standing with the association. (If a renter, please provide Membership Chair with current address when renewing.)
- Fees will be prorated **for new members, one-time only**. If joining in January, member will pay \$95.00 for the remainder of the current season through the end of the following season. If joining in February, member will pay \$85.00 for the remainder of the current season through the end of the following season. If joining in March, member will pay \$65.00 for the remainder of the current season through the end of the following season.

**Residents of Sun Lakes Country Club (Phase I) or IronOaks:** In addition to the \$65.00, must pay an annual HOA tennis fee to the Cottonwood/Palo Verde Homeowner's Association per the reciprocal agreements with these two Sun Lakes communities. A separate form is to be completed and a check, made payable to SLHOA#2, must be submitted at the association's administrative office. The fee covers 12 months from the date of payment. Contact the association's Recreation Directory for this form and payment.
